DOCUMENT DATA EXTRACTION

A convenient 'capture' process automatically extracts all relevant information from the documents using optical character recognition (OCR) and Al support. The extracted data undergoes additional 'data validation', which compares the extracted information with master data such as customer and product master data from SAP S/4HANA Public Cloud or other external data sources (e.g. as part of a customer or product match). Documents that cannot be reliably recognised are sent for manual verification or correction.

CONVENIENT ARCHIVING OF OUTGOING DOCUMENTS AND EXTERNAL ATTACHMENTS

Documents generated by SAP S/4HANA Public Cloud can be automatically archived in Kendox InfoShare. Outbound documents and external attachments are automatically archived via the SAP-certified InfoShare DocumentServer CMIS using secure, encrypted HTTPS connections. In addition, all relevant document metadata is automatically enriched via InfoShare Indexdownload CMIS, enabling efficient and comprehensive search via the Kendox InfoShare Web Client, which is intuitive and independent of ERP access.


DIRECT ACCESS TO CUSTOMER ORDERS AND OTHER DOCUMENTS
